I expressly agree to assume all risk of injury and death and loss to personal property which may result from my participation in these Fishing Tournament(s). In exchange for being permitted to participate in the Professional Walleye Trail tournament(s), I hereby RELEASE AND DISCHARGE the tournament organizer, In-Fisherman, a PRIMEDIA company, and the tournament sponsors, their officer's, directors agents, employees and legal representatives (the "Released Parties") from any and all liability for any injury, damage or other loss sustained by me which may arise from my participation in the above tournament, including, but not limited to, any claim I or my heirs may have for loss, personal injury or casualty of any kind, injuries, damages or other loss sustained by me caused by the negligence or strict liability of the Released Parties. I do not release the Released Parties from liability for willful or intentional misconduct. I realize that I am required to submit proof of boating liability insurance (see Rule I.-K.) to tournament officials in order to use my boat in tournament competition.
